ORDINANCE NO. 90 - 34

AN ORDINANCE OF HERNANDO COUNTY PROVIDING FOR THE AMENDMENT OF SECTION 12-92 OF THE CODE OF ORDINANCES, HERNANDO COUNTY, FLORIDA; PERTAINING TO THE CHANGE OF EXHIBIT 'A'; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ENACTED BY THE BOARD OF COUNTY COMMISSIONERS OF HERNANDO COUNTY, FLORIDA:

SECTION I AMENDMENT OF SECTION 12-92. Section 12-92 of the Code of Ordinances of Hernando County, Florida, is hereby amended to read as follows:

Section 12-92. Creation of Unit.

"For the purpose of creating, establishing, maintaining and operating a fire protection system within the area described herein, there is hereby created a municipal service taxing unit to be known as the "Northwest Hernando County Fire Protection Service Unit," which shall be all the property within the boundaries described in Exhibit "A", attached hereto and made a part hereof by reference, located in the county."

SECTION II INCLUSION IN THE CODE. It is the intention of the Board of County Commissioners of Hernando County, Florida, and it is hereby provided, that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of Hernando County, Florida. To this end, the sections of this Ordinance may be renumbered or relettered to accomplish such intention, and that the word "ordinance" may be changed to "section", "article", or other appropriate designation.

SECTION III SEVERABILITY. It is declared to be the intent of the Board of County Commissioners that if any section, subsection, clause, sentence, phrase or provision of this Ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect the validity of the remaining portions of this Ordinance.

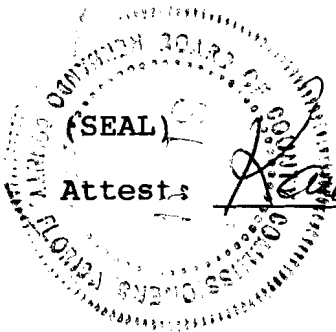

Sections 1, 2, 3, 4, 5, 6, East 1/2 of 9, 10 and 11 of Township 23, Range 17, including the incorporated City of Weeki Wachee, less that portion contained within the Spring Hill Fire District.

Sections 1, 2, 3, 4, 10, 11, and 12 of Township 23, Range 18, less that portion contained within the Spring Hill Fire District.
