BE IT ENACTED BY THE BOARD OF COUNTY COMMISSIONERS OF HERNANDO COUNTY, FLORIDA:

SECTION I AMENDMENT TO THE CODE. Section 12-92 of the Code of Ordinances of Hernando County, Florida, is hereby amended so that such section shall be read as follows:

"Section 12-92. Creation of Unit.

For the purpose of creating, establishing, maintaining and operating a fire protection system within the area described herein, there is hereby created a municipal service taxing unit to be known as the "Northwest Hernando County Fire Protection Service Unit", which shall be all the property within the boundaries described in Exhibit "A", attached hereto and made a part hereof by reference, located in the county."

SECTION II INCLUSION IN THE CODE. It is the intention of the Board of County Commissioners of Hernando County, Florida, and it is hereby provided, that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of Hernando County, Florida. To this end, the sections of this Ordinance may be renumbered or relettered to accomplish such intention, and that the word "ordinance" may be changed to "section", "article", or other appropriate designation.

SECTION III SEVERABILITY. It is declared to be the intent of the Board of County Commissioners that if any section,

subsection, clause, sentence, phrase or provision of this Ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect the validity of the remaining portions of this Ordinance.

SECTION IV EFFECTIVE DATE. This Ordinance shall take effect immediately upon receipt of official acknowledgment from the office of the Secretary of State of Florida that this Ordinance has been filed with said office.
